## **MNBP Reporter's Notebook: Taxes Up** 8.28%; 4% MAT on Hotels/Motels for 2025

The Municipality of Northern Bruce Peninsula has several controversial issues on its plate this winter and spring, which means it has several difficult decisions to make.

An upgrade to the municipal arena in Lion's Head has been paralyzed by spiralling costs compounded by recently discovered drainage problems at the existing arena site. Alternatives are being explored; a staff report is eagerly awaited.

Municipal infrastructure is aging, while the costs of improvements are rising much faster than inflation, also much faster than recent tax increases. This is especially true of roads, which are by far the largest single element on both sides of the municipal budget capital and operating.

MNBP's capital reserves — funds set

By John Francis, aside to fund long-term improvements are nowhere near adequate to deal with the looming shortfalls. Council recently agreed to increase taxes by an extra 1% and designate that for Capital Reserves, but Mayor Milt McIver has stated repeatedly that this is not nearly enough.

> Operating expenses are also increasing steadily — the Bylaw Enforcement department has more incidents to deal with each year, as does Fire and Emergency Services. These costs far outstrip overall inflation.

At its March 11, 2024 Meeting, MNBP Council passed the 2024 Budget, implementing a tax increase of 8.28% and a budget increase of 10.21%. Mayor McIver commented, "I'd like to see more going in to capital reserves; it doesn't take long to spend it...'

Long-term strategies to generate more revenue without increasing taxes

It is 5 years since we have had a full choir to perform on Good Friday! They come from all over the peninsula, from Tobermory in the north to Wiarton in the south, to rehearse each week in Lion's

In previous years, the Good Friday cantatas took the form of a Tenebrae Service incorporating the lighting and extinguishing of seven candles to leave the church in complete darkness by the end of the performance.

> I especially like what the character actors have to say. It's easy for us, 2,000 years later, to analyze the situation, point fingers and lay out how it all could / should have played out differently. The writers of this cantata have revealed that, 2,000 years later, we're no different than those people. I hope people will come away with a better understanding of why it happened this way and what it means in our lives 2,000 years later.

The music is the most difficult we have performed under my direction but the quality of the rest of the cantata made it worth the effort. The choir has risen to the challenge. Rehearsals are going really well and I am certain that this will be an excellent portrayal of the familiar story in a unique way. I'm really excited!

This cantata focuses on Good Friday rather than the entirety of the events of Holy Week. We can't be everywhere on Good Friday, so we will have our first performance on Palm Sunday, March 24, at 7:30 pm at Tobermory United Church (5 Brock Street). On Good Friday, March 29, you can attend performances at Bethel Evangelical Missionary Church in Lion's Head (18 Ferndale Road) at 10:30

am, and Cape Croker United Church (Pit Road and Community Centre Road, Neyaashiinigmiing) at 7:30 pm.

At Cape Croker United Church, the cantata narrations will come from the First Nations Version of the New Testament which was published in 2021. This may be of particular interest to those who are interested in learning more about Indigenous culture and how it intersects with Christianity.

## Our 2024 Budget Has Lost Sight of the Forest — It Barely Funds the Trees

The Municipality of Northern Bruce Peninsula recently concluded a gruelling budget process, arriving at a final set of numbers that will satisfy — pretty much

Taxes are going up 8.28% and the overall budget is going up 10.21%.

According to a Statistics Canada press release in February 2024, "The Consumer Price Index (CPI) rose 2.9% on a year-over-year basis in January, following a 3.4% gain in December."

Our resident tax scolds will be outraged by the tax increases. They will argue that the Consumer Price Index increases should be the upper boundary for municipal budget discussions.

Some who follow municipal governance closely are concerned that this budget leaves large gaps in the funding of our infrastructure and

The municipal roads budget got a big boost this year, but it was nowhere near enough to cover the increase in costs the department faces for materials and services. The roads budget will probably need an equally large boost again next year just to get its head above water. If we actually want improvements, it will take another large boost beyond that.

Then there's infrastructure. The Meeting Agenda for our Council's Feb 5 Special Budget Meeting included a list of 84 "built" assets the municipality owns or is responsible for.

A few of them have been built in the current century — Lion's Head lighthouse, the Ferndale information centre, some recycling buildings and washrooms and a couple of sand domes.

But there is also a daunting list of 19th century buildings - the Rotary Hall in Lion's Head, the SS#2 Schoolhouse/Museum in Tobermory, the two pioneer cabins at that museum and Tobermory Library. All of these require or will require significant investments to keep them serviceable but every one of them is different and presents unique challenges. For challenges, read "long hours of staff time figuring out how to solve problems and estimating budgets".

The rest of the 84 built infrastructure items date from the 20th century; many of them were built between 1945 and 1975, a 30-year period in which the populations of Ontario and Canada doubled. Almost by definition, they do not meet modern building and safety codes, which means every repair, renovation or improvement is complicated. Once again — long hours of staff time figuring out how to solve problems and estimating budgets.

Our municipal "built infrastructure" our buildings and facilities — are becoming increasingly inadequate as our population increases. We don't just need to fix the decrepit buildings we already have, we need to build new ones. A lot of

We desperately need a replacement for the Friendship Club building in Lion's Head — it is used almost daily but it is a money pit. You could probably spend a quarter million just figuring out whether or not the walls could support the new roof it needs. Nobody remembers what's under that panelling.

The Meeting Place building in Tobermory is also used almost daily. It needs a six-figure repair to its roof and HVAC systems. But if we make those repairs it will still be a clumsy, temporary building long past its designed lifespan.

Repairs and renovations to buildings have become much more expensive in recent years. Partly it's the cost of materials. Partly it's the new building codes. Partly it's that wages have gone up across Canada. Partly it's that dramatic local increases in the cost of housing have driven local wage costs up by more than the national average — nobody here can afford to work for minimum wage anymore because the cost of living is too high.

The costs of running our municipality have gone up a lot more than 10.21%. Somehow staff and Council will find a way to spread that money around

so that nothing actually falls down or washes out.

But even the 1% of the budget that will go into capital reserves doesn't begin to address what is needed.

In concentrating on all the trees, we lost sight of the forest.

There is nothing in the budget to address the desperate need for a water system in Tobermory. (Guesstimate -\$60 million).

There is nothing in the budget to replace the (decrepit) Friendship Club, the undersize library or the logistical problems at the arena (a new complex solving these problems and a few more would be around \$25 million.)

There is nothing in the budget to get Lion's Head municipal water to Ferndale. (I dunno — \$10 million maybe?)

There is nothing in the budget to address the need for a sewage system in Lion's Head. And so forth.

Add it all up, it comes to somewhere over \$100 million. Amortize a hundred million at 5% over 25 years and the payments are around \$6 million per year.

We send \$8 million a year to Bruce County and don't get much back.

Hmmm.

## **Letter: Powerful Public Opposition to Proposed Radiocommunication Tower**

For our small Dyers Bay community, 2024's holiday season brought some not-so festive news. On January 24th it was revealed to the public through the Bruce Peninsula Press that a company called Shared Tower Inc. proposes to install a 90m guyed radiocommunication tower at 75 Lindsay Rd. 40, right in the middle of our rural residential community. Alongside this announcement, citizens were asked to pose any concerns and inquiries - by January 26th.

Blindsided by this urgent news, residents were given only two short days to respond to proponent Shared Tower Inc. before the unexpected consultation period expired.

Responses from Shared Tower and the MNBP administrative staff were not forthcoming. Contacting council members directly, we were surprised to learn they, like the public, had no prior knowledge of the tower proposal.

Acting quickly, a concerned community member filed a Freedom of Information request hoping to gain additional knowledge that was clearly not being communicated to either public or council. The FOI request troublingly revealed that MNBP administrative staff, as opposed to elected councilors, had been communicating with Shared Tower for well over a year.

Although pre consultation with Land Use Authorities is the essential first step in the approval process for such a project, prep work on the site had been physically underway for over a year without LUA ever having been notified.

When asked why neither council nor public had been informed, MNBP staff stated they determined council didn't need to know about the proposal until government funded service CRINS (Canadian Radiocommunications Information Notification Service) submitted its report.

Unfortunately the FOI also revealed that Shared Tower and MNBP administrative staff were aware that

CRINS was unresponsive to any attempted communications since the proposal's origin in 2022, and its report was over 100 days past its due date. In other words, public was told access to vital information was contingent upon a long overdue report that they had good reason to believe would never materialize.

We voiced concerns and objections through numerous emails, phone calls, and no fewer than four delegations to council meetings in January through March. We asked about work beginning without input from the LUA regarding proper zoning, and the meagre 2-day solicitation of public input. We asked about an environmental impact study. None has been done, although the proposed site is nearly surrounded by protected land rich with mature forest, wetlands, and wildlife, including several endangered species.

At one council meeting the Shared Tower planning manager provided detailed maps illustrating that there would no practical improvement to coverage along the Dyers Bay shoreline and at Gillies Lake where residents and cottagers are concentrated.

Troubled by these revelations, our community is attempting to compel Municipal council to issue a vote of non-concurrence on the basis that we've definitively demonstrated that CRINS protocol wasn't followed. This would simply indicate that the council doesn't agree that the proposal was handled adequately, requiring Shared Tower Inc. to restart the application process should they so choose.

With the failure of CRINS brought to light, our community expected the role be transferred to federal institution ISED (formerly Industry Canada), the default regulating body. Instead, we were surprised that a new custom protocol was hastily created for MNBP administration. This new protocol bypasses normal procedure and relinquishes council's power to issue a statement of non-concurrence. We appeal to council to reaffirm their responsibility to ensure proper procedure is followed, and ensure that decisions are made with public concern in mind.

Since this reticent proposal was initiated, before it was made public, several properties near the proposed site had been purchased and built on, meaning those homeowners made major investments completely unaware that an industrial scale project was underway just down the street. Further, a single mother on disability will be forced from her home due to health concerns if this tower is constructed.

If Municipal council has heard our voices, their only reasonable choice is to vote non-concurrence and prompt the approval process to begin again, this time properly.

On a final note, a similar 2015 tower proposal in this exact same community was ultimately rejected due to powerful public opposition. Currently there is far greater opposition than was observed in 2015 - and the same objections stand: no necessity has been shown; the tower would be a visual blight in a lovely natural area; and many - most - of the people living near the proposed site object to its construction, will derive no benefit but will be forced to live daily with the negative consequences.



Bruce County Planner, Megan Stansfield, appeared in person at the February 26, 2024, Council Meeting.

Deputy Mayor, Rod Anderson, welcomed Megan Stansfield to the meeting.

Megan Stansfield provided an overview of Zoning By-law Amendment Z-2024-001 (Hicks c/o Davidson), the following

- This application proposes to sever 11.47 hectares of farmland and merge this parcel with an abutting lot to create a 51.88 hectare farm; and, to retain a 26.36 hectare farm lot. No new lot will be created as a result of this lot line adjustment. This application further proposes to amend the Municipality of Northern Bruce Peninsula Zoning By-Law by reducing the minimum lot area requirement of the RU1 zone from 39 hectares to 26.36 hectares as required to facilitate the severance.
- This zoning by-law amendment is to permit an agricultural lot with a minimum lot area of 26.3 hectares. The zoning by-law requires a minimum lot area of 39 hectares for agricultural lots. The proposed amendment facilitates

the severance/lot addition of an approximately 11.5 ha portion of the property at 512 They Bury Road, and addition to the adjacent parcel. The resulting retained parcel will be 26.3 ha and, as demonstrated in the Planning Justification Report, the lot area is sufficient for the current and future use of the property, as a horse farm.

- The property is designated as Rural and Agricultural in the County Official Plan. The agricultural consent policies apply in this case and the provisions for a severance require that the severed and retained parcels are generally 40 hectares in size. The Official Plan allows for smaller lots provided that:
- 1. the severed and retained will be used for agriculture;
- 2. similar sized lots are unavailable within a 25km radius; and,
- 3. the size of each lot is suitable for the intended agricultural use.
- The Planning Justification Report details how the proposed retained lot still meets these requirements. In
- 1. the proposed retained lot is an established horse farm, which operates on a portion of the land, while the severed lot will continue use as a cropped field.
- 2. The retained 26 ha will be sufficient

for the use of a horse farm and it is unreasonable to assume that the operation could be moved to a different parcel, even if one was available.







## **Bruce Men's Shed Spring Into Action**

Submitted by The Bruce Men's Shed As spring arrives today (March 19) we are gearing up for outdoor activities and to that end we are building bat houses for our resident species, the little brown bat and the big brown bat.

Based on recommendations from Canadian bat specialist Karen Vanderwolf of the University of Waterloo, we designed and built a number of threechamber houses that will be installed and monitored by Nature Conservancy Canada on properties on the Bruce Peninsula. We will also be making smaller versions that homeowners might want to purchase as well.

With so many skills within our group, we want to make a point of teaching while we gather to build these houses. We learned about operating a radial arm saw, a table saw, and using a table saw to run dado grooves in the wood. The dado slots make for a perfect fit. I'm sure that the bats will really love the boxes.

We learned techniques for gluing up and nailing the boxes together using a pneumatic nailer. Lee Brown, who is a dynamo in the workshop, walked us through the steps from start to finish. Michael kindly let us use his workshop to do final assembly, in a warm space too!

Next month Bruce Men's Shed will celebrate its first full year and we are planning a breakfast event to be held at the Lion's Head Legion noted at the end of this article. At a kickoff breakfast in April last year we had 44 men come out. At that time we had about 15 members, and now almost a year later, we count more than 70 and over one third are regular attendees.

Our latest venture, cooking/baking classes led by Chris Koos got off to a soft start. Soft in that a few guys got together in test classes to make what Chris calls "breakfast boats" the first week and muffins and scones the next week. I can attest that they were delicious.

In preparation for our anniversary breakfast we will continue sampling recipes that we can duplicate the morning of the April meeting.

In coincidental timing, a few of us attended a webinar hosted by Men's Sheds Ontario, the topic was "Nutrition for Senior Men" which of course applies to all seniors

our tax money as we do and strongly recommended that we do a cost/benefit analysis on that money. He asked other Council members for feedback.

Mayor McIver agreed that a cost/ benefit analysis was a good idea. He asked if a consultant should be engaged

CAO Peggy Van Mierlo-West stated that staff would love to do this themselves, but it is simply too large an undertaking. She offered to prepare a report for Council's next Meeting with information concerning costs.

Councillor Dowd wondered if we could put the shoe on the other foot and get the county to tell us what they give us. The Deputy Mayor argued against this, suggesting that "it would be interesting to compare our numbers with theirs". Mayor McIver agreed, noting that he had discussed this with county administrators, asking for a summary of county expenditures in MNBP. "They are counting on doing that," he said, "but I think it's important that we do it too".

Councillor Golden was cautious about spending money on this and wondered what the possible outcomes might be. Is it legally possible to leave the county?

The Mayor suggested a more nuanced approach. If there's a huge discrepancy between what we're sending and what we're getting back, we have to prove it. Just saying we're getting a raw deal isn't enough. But we also need to look at reality — what is possible?

The CAO explained that other small municipalities have tried to deamalgamate and have found that they could not do it. "But we can evaluate what we are getting in services; should we find that there are discrepancies and want to change that, we can start a negotiating process with the county" Are the various county services a benefit to us? If not, why are we contributing to them? "We need to have that conversation. My belief is that at the end of this process, we will end up with a better relationship with the county."

The CAO will bring a report to the next Council Meeting suggesting next steps and anticipated costs.

#### **Proposed Communications Tower on Lindsay Rd 40**

Shared Tower Inc proposes to install a telecommunications tower at 75 Lindsay Road 40 (the first concession north of Dyers Bay Road). The proposal has run into stiff resistance from some local residents and landowners. In letters and delegations to Council, they cite numerous studies linking microwave towers to health concerns, even cancers. They also claim the public consultation process was not conducted properly.

Shared Tower presented to Council on Feb 12. They stated that Federal regulations require that microwave radiation be kept to less than 2% of the level shown to cause harm. The Shared Tower facility will introduce a further safety margin — it will be limited to 2%of the amount they are permitted. They presented 62 letters of support.

On March 11, MNBP Council received a delegation of four presenters opposing the tower. (Their documentation can be found online in the Agenda for the Mar 11 Meeting.)

After the presentations, Councillor Golden kicked off the discussion by stating that her only concern was whether the consultation process was compliant. "The science is not for us to

Mayor McIver agreed that there is a process to follow. Council is waiting on a staff report as to whether the process followed the rules.

The CAO stated that there are a few things Council is waiting on, one of which is a letter from the municipality's lawyer addressing whether or not to start Homecoming Weekend"

#### 4% MAT Will Apply to Motels, **Hotels for 2025**

One of this Council's objectives is to find ways to make "tourism pay for tourism". Property owners have long complained that it was unfair to pay for tourism-related expenses — washrooms, parking lots, bylaw enforcement, emergency response — out of property tax revenues. In a move to address this, the 2018-22 Council implemented a 4% Municipal Accommodation Tax on Short-Term Accommodations, aka STAs. (STAs are residential properties that are rented commercially for periods of less than 30 days.) After much discussion, the current Council voted on March 11 to extend the 4% MAT to hotels, motels, hostels, cabins, cottages and Bed and Breakfasts, (but not on campgrounds or marinas) beginning Jan 1, 2025.

Council members were not entirely comfortable with this decision. Councillor Todd Dowd pointed out that a lot of commercial operators oppose this, despite the fact that their Chamber of Commerce will benefit (half of MAT revenues must be given to a tourism-supporting organization, Tobermory Chamber of Commerce in this instance). He noted that he had yet to hear any suggestion of an alternative way of generating comparable amounts of revenue.

Mayor McIver noted that the business community wants to know where the MAT revenues will be spent.

Councillor Smokey Golden stated that Council had received many presentations in recent years; opposition to this kind of initiative is not new. STA operators resisted the licencing initiative and the MAT just as commercial operators are resisting now. "It's fair to say there are mixed feelings." She pointed out that Council had agreed at its last meeting not to implement the MAT extension in 2024 but in the long term, MNBP needs to "bite the bullet — I'm not sure we'll ever get 100% support."

Councillor Aman Sohrab is Council's representative on Tobermory Chamber of Commerce; he has been privy to business reaction to the proposed changes. He argued for implementing a 2% MAT on commercial operators, not 4%. He suggested that commercial operators pay commercial taxes and have to meet many onerous regulations from which STAs are exempt. The 2% reduction was a matter of fairness. Councillor Golden agreed that it would be good to meet businesses part way. She felt that adding 4% to a bill might make a difference between people coming and not coming, whereas 2% "seems innocuous".

Councillor Sohrab suggested that MNBP could always raise it from 2% to 4% at a later date. Mayor McIver argued that if you're going to 4%, you might as well start there.

Treasurer Teresa Shearer explained that charging two different rates would introduce a lot of complication. Many residential properties are owned and operated by commercial accommodators. What rate do you charge them and how do you decide? She suggested a single rate is preferable. In the end, Council followed her suggestion.

## **Upcoming SOK Talk Sheds Light** on Sustainable Tourism and **Bruce Trail Conservation Efforts**

The Sources of Knowledge (SOK)Board, in collaboration with the Peninsula Bruce Trail Club (PBTC), invites the community to a presentation focused on sustainable tourism and conservation efforts along the Peninsula section of the Bruce Trail. The upcoming presentation will highlight the journey of the Peninsula Bruce Trail Club from 2020 to the present, discussing the challenges faced, the collaborative efforts undertaken with local stakeholders, and the strategies developed for sustainable tourism and trail conservation. Attendees will also learn about future plans to ensure the continued enjoyment and preservation of the Peninsula section of the Bruce Trail.

#### SUSPICIOUS VEHICLE **RESULTING IN 25 CHARGES**

(SOUTH BRUCE PENINSULA, ON) One individual is facing 25 charges when a property owner called the Grey Bruce Ontario Provincial Police (OPP) to report seeing a suspicious vehicle on their seasonal property through their video surveillance.

On March 6, 2025, at 3:19 a.m., a property owner called the Grey Bruce OPP to report a vehicle parked in the laneway of their vacant seasonal property on Davidson Drive in South Bruce Peninsula.

Approximately street value of the drugs is \$70,000.

- · Possession of Firearm or Ammunition contrary to Prohibition Order X8
- · Fail to comply with Probation Order
- · Possession of a Weapon for a Dangerous Purpose X3

The accused was held for a bail hearing.

The Grey Bruce OPP is reminding everyone to report suspicious activity to police. We would rather prevent a crime than have to deal with the consequences of crime.

#### LOAD RESTRICTION "HALF LOAD SEASON"

(GREY BRUCE, ON) - Many roads in the Grey Bruce area are subject to load restrictions between March 1 -March 31 yearly. This date may change depending on road conditions.

The Grey Bruce Ontario Provincial Police (OPP) in partnership with the Ministry of Transportation (MTO) will be conducting Commercial Motor Vehicles (CMV) checks on vehicles that are exceeding the reduced load restrictions. OPP officers will be equipped with scales that are to be used to weigh up individual axles on Commercial Motor Vehicle. Axles that exceed 5000 kilograms are considered to be in violation. Officers will patrol side roads with clearly marked signage indicating half load restrictions. Provincial highways and some major county roads will be built to higher capacities and exempt from the half load restrictions. Please check with your municipality for a full list of half load roads, most of these roads have signage displayed.

Exceeding the weight restrictions on Municipality, Township, and County roads has a negative effect by causing damage to roads which further results in a negative economic impact.

Road safety is a priority for the OPP and officers are trained in Standardized Field Sobriety Testing (SFST) and as Drug Recognition Experts (DRE), giving them the skills to identify a driver who is impaired by a drug. Officers can also use Approved Drug Screening Equipment to enforce zero tolerance sanctions with young, novice and commercial drivers.  $\bar{\text{I}} f$  you suspect that someone is driving while impaired by alcohol or drugs, it is important to call 9-1-1 to report it.



## **GBPH Encourages Residents To Test** Their Well Water This Spring

March 15, 2024 - Grey-Bruce households that draw drinking water from wells and other private systems should test their water regularly to ensure it is safe to consume, as wellwater quality can change over time.

Grey Bruce Public Health is reminding residents that spring is an ideal time to test well water.

"While we're unlikely to experience the significant snow melt and flooding conditions of a typical Grey-Bruce spring, Public Health still encourages residents on privately owned systems to test their drinking water this spring by taking advantage of Public Health Ontario's free well water testing program," says GBPH Senior Public Health Manager Andrew Barton.

Well water should be tested at least three times a year, so making it a habit to test in the spring, after each winter season, is a good idea."

Grey Bruce Public Health launched last fall a locally designed service that ensures all residents have equitable, timely access to Public Health Ontario's complimentary well water testing program.

Residents can pick up sample collection kits and drop off samples at 14 locations throughout Grey-Bruce.

A map of the locations, along with information on when to collect samples and drop them off, is available on GBPH's Private Drinking Water webpage (https:// www.publichealthgreybruce.on.ca/ Your-Environment/Safe-Water/Private-Drinking-Water).

Water samples must be tested by PHO within 48 hours of collecting the sample. Therefore, residents must collect and drop off their samples as close as possible to the scheduled courier pick-up time.

Public Health Ontario's private drinking water testing program analyzes samples for the presence of bacterial indicators of contamination, specifically E. coli and total coliforms, which can make people sick and can even be fatal. Residents receive test results directly from PHO.

If a test comes back with an adverse result, residents can call Grey Bruce Public Health for assistance. There are many ways to deal with water contamination to ensure your family is

## **Biosphere Hosted Heat Pump Workshop a Huge Success**

On February 24, 2024, the Bruce Peninsula Biosphere Association, in collaboration with the municipality's Climate Action and Waste Diversion Committee, hosted a workshop to explain how heat pumps work and the benefits to both our climate and to users. More than 50 people attended the workshop at the Rotary Hall in Lion's Head, an outstanding turnout!

Local experts shared their knowledge on energy audits, heat pump uses and the installation process along with local users who shared their own case studies. The audience was very engaged and had many questions for our presenters.

In Canada, more than 700,000 heat pumps are installed nationwide (Global Newswire) and throughout the U.S., heat pumps are now surpassing gas furnace sales (New York State Energy and Development Authority).

## Submitted by Donna Cole, What is an Energy Audit?

Dan Blenkinsop from Greenbrain Inc., shared detailed information about energy audits and grant programs.

An energy audit includes calculating the heated volume of your home, determining the heat resistance of the building envelope, counting the number of rough openings in the house, documenting the HVAC system, and performing a blower door test to calculate the home's air tightness. Once these audits are completed, a homeowner will know how to increase the efficiency of the home to save on energy costs and reduce greenhouse emissions. This is a key step in understanding how a heat pump system can help.

air conditioning. A heat pump works just like an air conditioner in the summer, absorbing heat from the inside air and sending it outside via the change of state of the refrigerant in the lines. In the winter the system reverses and provides heat indoors very efficiently" explained Eric. You can convert your current ducted furnace system to a heat pump system and reuse the current ductwork.

If running ductwork through your house isn't appealing (or readily available), consider "ductless split" heat pumps as an option. These are extremely efficient and can provide variable temperatures for different rooms or parts of your home as needed.

#### Case Studies from Local Residents: Saving Money and Reducing Greenhouse Gases in Tobermory

Mike Campbell from Tobermory shared their family's decision on why they wanted to transition to a heat pump from a propane furnace and woodstove system. According to Mike, "We wanted to reduce the amount of greenhouse gases that we used as a family, and we also wanted to save money by switching to a more efficient heat source. We completed the energy audit and made improvements to the efficiency of the home. We then installed a ducted heat pump. Our annual savings in reducing propane and wood consumption saved us over \$1,500, and over 5,600 kg of carbon last year! With our Green Energy

rebate and annual savings, we will have paid for the installation within 7 years."

#### Lion's Head Heat Pump Works with In-Floor Heating Saves Propane, Wood, and Reduces CO2

Rod Layman from Lion's Head shared how he installed a heat pump to work with his hydronic in-floor heating system. The system worked so well that he installed a radiator on the second floor, where there had been no heat before, as well as in his shop, heated a hot tub, and a portion of his domestic hot water. Rod reduced his CO2 emissions by 8,000 kg/year, and reduced propane use to zero from 1,300 litres per year, and wood from 12 cords to 6. His net savings amounted to \$600/year with increased electricity costs offset by no propane and less wood. But also, Rod has converted to an induction stove from propane, and has switched to an electric car. If you add in gasoline saving, Rod is saving \$1,800/ year. Lower carbon emissions, a more comfortable home, and less money spent on fuel. That's a win/win/win!

## Public Health Issues Opioid Alert Following Multiple Drug Overdoses Within 24 Hours

Media Release

March 5, 2024 – Grey Bruce Public Health is urging people who use unregulated street drugs to exercise extreme caution with every dose after receiving reports of multiple suspected opioid-related overdoses/poisonings within a 24-hour period.

The overdoses happened March 4 and 5, primarily in the Owen Sound area. Two of the overdoses – one involving an individual in their 30s and another involving a person in their 40s – were fatal. One of the fatal overdoses took place in Port Elgin.

Fentanyl – the highly potent opioid that is both tasteless and odorless – is believed to be the substance responsible for the overdoses.

"We have received reports of local street drugs containing fentanyl that has been unevenly mixed with other substances. This uneven distribution of fentanyl can result in the toxicity of one dose being very different from another dose, even within the same batch. This, in turn, increases a person's risk of experiencing a drug poisoning," says GBPH Harm Reduction Program Manager, Monica Blair.

"These reports underscore the importance of following critical harm reduction strategies, such as starting with a small amount and increasing slowly while monitoring the drug's effects. This should be done for each dose."

Grey Bruce Public Health is advising the public that people who use drugs are at significant risk of overdose due to the local street drug supply containing the highly toxic drug Fentanyl or Fentanyl analogues.

GBPH urges people to have a sober friend with them when using drugs or to call or text the National Overdose Response Service (NORS) or use/download the BRAVE App if using alone.

NORS can be reached by calling or texting 1-888-688-6677. A NORS operator will stay on the line with the person while the drug is used. In the event the person becomes unresponsive, NORS will call 911 to ensure help arrives.

## Other harm reduction recommendations include:

- Taking extra caution if mixing drugs.
   Mixing drugs, including alcohol, increases the risk of harm and overdose.
- Using only new supplies and avoid sharing supplies. This reduces the risk of getting or passing on an infectious disease. Supplies are available at GBPH and community partners.
- Getting overdose prevention training and carrying a Naloxone kit. Naloxone is available for free at most local


